BlueCare Plus Tennessee

1 Your Flex Card

In 2026, your prepaid flex card will be loaded with your **\$378 combined monthly allowance** you can use on:

- › Over-the-counter (OTC) items
- › Transportation
- › Healthy food*

You can use this allowance for OTC items and rides to plan-approved locations through Uber Health. If you qualify for the healthy food benefit*, you can also use your combined monthly allowance on approved healthy food items like fruits, veggies, canned goods, dairy products and more. This allowance doesn't roll over at the end of the month.

2 \$0 Premiums, Deductibles and Medical Copays

You pay nothing for your premiums and deductibles on our plans. And in 2026, you'll have **\$0 copays** for all covered medical services.

3 Prescription Savings

You can often save money on your drugs by getting generic versions instead of brand names. You can also ask your doctor if you can get a **90-day supply** of your drugs.

4 MyHealthy Rewards

Sign up for MyHealthy Rewards in 2026 to earn gift cards** for certain health screenings. You can also earn a **\$10 gift card** when you sign up online and log in to your account.

Some of your 2026 benefits

	2026 Benefits ¹
Hearing Services	One routine hearing exam per year from a TruHearing® provider and two TruHearing-branded hearing aids (one per ear) every three years
Vision Services	\$400 yearly allowance for covered supplemental vision care, one routine eye exam each year and limit of one pair of eyeglasses (lenses and/or frames) or contact lenses each year
Over-the-Counter/ Healthy Food Items²/ Transportation³	\$378 allowance per month (no rollover)
Meals	Receive 28 meals after you're discharged from a qualifying inpatient hospital or skilled nursing facility.
Fitness Program	This includes online resources and access to participating local gyms (included at no extra cost).

BlueCare Plus Tennessee is an HMO D-SNP plan with a Medicare contract and a contract with the Tennessee Medicaid program. Enrollment in BlueCare Plus Tennessee depends on contract renewal.

The healthy food benefit listed is a special supplemental benefit for members with certain chronic conditions. Qualifying chronic conditions include, but aren't limited to, cardiovascular disorders, diabetes mellitus, obesity, chronic lung disorders and chronic gastrointestinal disorders. Additional qualifying conditions exist. See plan materials for complete list. Not all members (even those with a qualifying condition) qualify. Eligibility is based on meeting the CMS definition of "chronically ill enrollee" and all applicable plan coverage criteria. TruHearing is an independent company that provides hearing products and/or services for BlueCare Plus Tennessee. TruHearing does not provide BlueCare Plus Tennessee branded products and/or services. TruHearing is solely responsible for the products and/or services they provide. We provide members with a flex card to use for select plan benefits. Value of the flex card is preloaded with certain amounts, according to benefits. Value of card may be zero. Card may not be used at all merchants or providers. Merchants and providers must accept major credit cards. Purchases may be restricted to certain types of items and services. Benefit limits may apply. Check your Evidence of Coverage for details. Or give us a call. TennCare is not responsible for payment for these benefits, except for appropriate cost sharing amounts. TennCare is not responsible for guaranteeing the availability or quality of these benefits. Gift cards are available to eligible members as part of the BlueCare Plus Rewards and Incentives Program. Total rewards and health actions are dependent on eligibility for specific activities, which will vary by individual. Members may not qualify for all health activities. One reward per healthy activity per year. Dates of service must be in the current plan year. Rewards will be administered once the claim is processed, which can take up to 90 days. Activities that earn rewards are subject to change.
